


**Fort Bend County Emergency Services District No. 4

Notice is hereby given that the Board of Commissioners (the "Board") of Fort Bend County Emergency Services District No. 4 (the "District") will hold a regular Board meeting at 4:00pm on Tuesday, August 25, 2020 at the Fulshear Simonton Fire Department Station #1 located at 30626 Fifth Street, Fulshear, Texas 77441. The Board will discuss, consider and possibly take action on the following matters:

Public Comment – Each member of the public who desires to address the Board per speaker; responses to public comment about matters not on the agenda may speak one time only and will be limited to 3 minutes.
