Ms. Adams then presented to the Board the Order Designating Public Hearing for Review of Petition for Inclusion into the District (the "Order Designating Public Hearing"), a copy of which is attached hereto. A discussion ensued regarding scheduling the public hearing for February 13, 2025 at 8:00 a.m. Ms. Adams noted that a Notice of Public Hearing was required to be published in the local newspaper, as well as physically posted within three (3) places in the District and one (1) place within the proposed area to be annexed. Upon motion by Commissioner Pechukas, seconded by Commissioner Melanson, after full discussion and the question being put to the Board, the Board voted unanimously to adopt the Order Designating Public Hearing and authorize publication of notice of same in the *Fort Bend Herald*.

There being no further business to come before the Board, the meeting was adjourned at 8:24 a.m.
